Specifically, NIH funds may not be used to support any Diversity Equity and Inclusion (DEI) related activities that were proposed in the application, or for any other DEI-related research or training activities, or programs. A term and condition to this effect will be included in any Notice of Grant Award. In addition, NIH funds may not be used to support research activities involving climate change, vaccine hesitancy, gender identity, or collaborations with China.

If this award involves human subjects research, information regarding study participant "gender" should not be collected. Rather, "sex" should be used for data collection and reporting purposes.

Updated NIH Policy on Foreign Subawards (NOT-OD-25-104) 05/01/2025

- NIH is establishing a new award structure that will prohibit foreign subawards from being nested under a parent grant
 - Prime award with linked independent awards
- NIH anticipates implementing the new award structure no later than September 30, 2025
 - Also plans to expand to domestic subawards
- Applies to all monetary foreign collaborations.
 - Does not apply to foreign consultants or vendors
- Until details are released, NIH will not
 - Issue new, renewal or non-competing continuation awards that include a subaward to a foreign entity
 - Not accept prior approval requests to add a new foreign component or subaward to an ongoing project
- ICs can renegotiate awards to remove subawards to foreign entities
 - If a project is no longer viable without the foreign subaward, will negotiate a bilateral termination of the project

- Rescinds NIH Implementation of the U.S. Government Policy for Oversight of Dual Use Research of Concern (DURC) and Pathogens with Enhanced Pandemic Potential (PEPP) (NOT-OD-25-061), released 01/10/2025
- NIH will issue revised guidance within 120 days (09/04/2025)
- NIH will not fund gain-of-function research

Points to Consider when Assessing Reasonable Costs

- Amount of publication cost in relation to NIH award
- Other works researchers may wish to produce during an award period
- Professional and institutional priorities
- Sustainability in terms of the library budget, laboratory budget, and other relevant budgets, if such costs were to be consistently paid
- Relevance of the journal in communicating findings to advance science and/or improve health outcomes
- Suitability of the journal's target readership for the dissemination of the content

- NIH has temporarily disabled the No-Cost Extension functionality in eRA Commons
- Director of NIH has directed NIH staff to review all existing grants and cooperative agreements to ensure NIH awards do not fund offmission activities or projects
- At this time, all NCEs must be submitted as a prior approval requests in eRA Commons

Early-Stage Investigators

- Within 10 years of completing their terminal research degree or postgraduate clinical training, and
- Have not previously competed successfully for a substantial NIH independent research award

To addresses delays impacting applications between January 1, 2025, and May 31, 2025, investigators whose last ESI-eligible submission date was

- October/November 2024,
- February/March 2025, or
- June/July 2025

will be extended ESI eligibility through October 2025.

- ESI end dates updated by June 8, 2025
- Investigators may confirm their status via the Education section



NIH Operates Under a Continuing Resolution (NOT-OD-25-084) 04/03/2025

On March 15, 2025, President Trump signed the Full-Year Continuing Appropriations and Extensions Act, 2025 (Public Law 119-4)

- Continues government operations through September 30, 2025, at FY24 levels (no reductions)
 - ICs may, at their discretion, issue non-competing awards at a level below that indicated on the most recent NOA
- Policies
 - Legislative Mandates (NOT-OD-24-110) remain in effect
 - Salary Limitation for Grants and Cooperative Agreements
 - Ruth L. Kirschstein National Research Service Award predoctoral and postdoctoral levels

- 03/15/2025 Full-Year Continuing Appropriations and Extensions Act, 2025 (Public Law 119-4) signed into law
 - Restricts the amount of direct and indirect salary to Executive Level II
- 01/02/2025 Office of Personnel Management increased Executive Level II to \$225,700
- No additional funds will be provided
 - Grantees may re-budget if adequate funds are available

Updated Procedures for Childcare Costs for Ruth L. Kirschstein National Research Service Award (NRSA) Institutional Research Training Awards (NOT-OD-25-100) 04/25/2025 https://grants.nih.gov/grants/guide/notice-files/NOT-OD-25-100.html

- Previously: NIH provided annual childcare costs for each full-time predoctoral or postdoctoral NRSA trainee appointment slot at the time of award
- New: NIH will provide annual childcare costs for 25% of the slots
 - If more than 25% of the trainees have eligible childcare costs, then the recipient may request additional costs via an administrative supplement
- Why the change?
 - Childcare costs are restricted and cannot be rebudgeted
 - Utilization of childcare costs were reviewed and determined to be less than 100%

- While nothing formal is in effect or challenged in the courts.
 The memo outlines DoD plans to Notify OMB of this change within 21 days of the issue of the Memo and Develop formal policy and procedure around this move.
- Anticipate more formal direction on or about June 4th.
- The proposed change will only impact Financial Assistance Awards (Grants and Cooperative Agreements). Contracts and awards from NSRI would not be impacted.

National Science Foundation May 2, 2025 Policy Notice: Implementation of Standard 15% Indirect Cost Rate NSF 25-034

- Policy Notice issued May 2nd.
- Lawsuits followed and is currently under a TRO until June 13th.
- NSF is temporarily pausing implementation of the NSF Policy Notice: Implementation of Standard 15% Indirect Cost Rate, NSF 25-034, through June 13, when a hearing is scheduled to occur in the United States District Court for the District of Massachusetts.
- New NSF awards issued during this pause will not implement NSF 25-034, but will include a term applying NSF 25-034 for the entirety of the award upon a court decision permitting application of the policy.

Justice Department Establishes a Civil Rights Fraud Initiative

- The Department strongly encourages anyone with knowledge of discrimination by federal funding recipients to consider filing a qui tam action under the False Claims Act.
- Nothing directly impacting our Day-to-Day operations, but it is encouraging individuals to report supposed / presumed violations.
- Somewhat related Big 10 peers are seeing more FOIA requests on newly issued awards. UNMC has received to such FOIA requests on new projects that involve animal work.
- Anticipate more inquires on newly issued awards.
