

NIH Common Forms: Biographical Sketch and Other Support

Effective Date: January 25, 2026

- Applicants are required to use the NIH Common Forms for proposals with due dates on or after January 25, 2026 and for all JIT, RPPR, and prior approval requests submitted on or after January 25, 2026.

Other requirements:

- All Senior/Key Personnel must have an ORCID ID and link it to their era Commons profile and their Common Forms
- Senior/Key Personnel must use ScienCV to draft and sign the Common Forms
- The biographical sketch and OS have no page limits, though certain sections may have specified limits

NIH Common Form Biographical Sketch Format

Identifying Information, Organization and Location

A. Professional Preparation

List training and education in reverse chronological order. Include postdoc, fellowship training, and undergrad degree.

B. Appointments and Positions

List all academic, professional, or institutional appointments in reverse chronological order. Begin with the current position. Must only identify all domestic/foreign positions outside of the primary organization within the past 3 years of the date the applicant submits the proposal to the sponsor.

C. Products

Provide up to 5 products closely related to the proposal project and up to 5 other products that highlight the S/K person's Significant Contributions to Science. Acceptable products: publications, conference papers, and presentations; website(s) or other Internet site(s); technologies or techniques; inventions, patents, patent applications, and/or licenses; and other products, such as data, databases, or datasets, physical collections, audio or video products, software, models, educational aids or curricula, instruments or equipment, research material, interventions (e.g., clinical or educational), or new business creation.

NIH Biographical Sketch Supplement

A. Personal Statement

Briefly describe why you are well-suited for the role in the project. Can include active projects and projects completed within the last 3 years to highlight experience. Limited to 3,500 characters.

B. Honors

List relevant academic and professional achievements and honors. Limited to 15 entries.

C. Contributions to Science

Describe up to 5 of the S/K personnel's contributions to science. May reference up to 5 products listed in the Other Significant Products section that are relevant to the contributions. There is no specific format for referencing the product, but it is encouraged to list the title, author's last name, publication, and/or year of publication. Do not include citations. Each contribution is limited to 5,000 characters.

Certification

S/K personnel signs certification to the accuracy of the biosketch, that they are not a party to a malign foreign talent agency, and they have taken required security training.
